SUGAR DIVISION



The Premier Sugar Mills & Distillery Company Limited.

Mardan, KPK

The mill was commissioned in 1950 as the largest sugar factory in Asia, later complemented by the addition of a sugar beet plant to enhance sugar production. The plant has a crushing capacity of 4,000 metric tons per day. Recently, the company inaugurated a fully automated plant for jaggery production, with a capacity of 1,000 tons per day.

Frontier Sugar Mills and Distillery Limited.

Takht-e-Bhai, KPK

The mill was established in 1951 and was acquired by the Premier Group in 1987. It comprises a beet plant, a sugar cane crushing facility, and a distillery plant. The mill has a crushing capacity of 1,700 tons per day.



Chashma Sugar Mills Limited - Unit I

The mills was set up in 1991 and so far helped growers to develop approx. 60,000 acres of land for the sugar cane supply by providing technical expertise and growing techniques. The rated crushing capacity of Unit-1 is 12,000 MT.

Chasma Sugar Mills Limited - Unit II

Ramak, D.I.Khan KPK

The mill was established in 2005 at Ramak, Dera Ismail Khan, KPK, with a crushing capacity of 6,000 metric tons per day. The Group has helped growers develop over 51,000 acres of land and provided technical assistance for the cultivation of high-yield cane varieties.





ETHANOL DIVISION

Chasma Ethanol Fuel Plant

Ramak, D.I. Khan, KPK

Chahsma Ethanol plant is the epitome of ethanol production in Pakistan, with a capacity of 100 metric tons (125,000 liters) of ENA (Extra Neutral Alcohol) per day, using sugar cane molasses as feedstock. It produces the highest quality ethanol in its class. The plant operates with two state-of-the-art ENA plants, designed by M/s Interis SAS, France, with a combined total capacity of 152 metric tons (190,000 liters) of ENA per day with guaranteed minimum ethanol strength of 96.2% v/v.


FUTURE EXPANSIONS

Premier Grain Ethanol Limited Punjab.

Premier Group has embarked on establishing Pakistan's first-ever grain-based distillery plant, named Premier Grain Ethanol Limited. The plant will have a production capacity of 240 metric tons (300,000 liters) per day of ENA, ENA Anhydrous, and Fuel Grade Ethanol. It will be a state-of-the-art facility based on European technology, using maize as the primary feedstock. The plant's commercial operations are planned to commence by 2026-2027.

Ethanol from maize has significant carbon-neutral potential: the carbon released during the combustion of ethanol or the use of DDGS (Dried Distillers Grains with Solubles) is offset by the carbon absorbed during maize growth. This gives maize-based ethanol a much lower environmental impact compared to fossil fuels. Furthermore, maize-based ethanol integrates seamlessly with gasoline, allowing it to be easily incorporated into existing fuel systems without the need for extensive modifications. These characteristics make maize an effective resource for ethanol production, contributing to both ecological sustainability and energy resilience.


